- a. Student Success Lisa Carlson
  - 10 Mines women applied and were accepted to NSF-funded scholarship program through WiSE; these are \$5,000 scholarships renewable for up to two years.
  - ii. Library is working on digitizing theses and dissertations published prior to 2021.
  - iii. Library online usage is increasing. Novel usage doubled to more than 44,000 hits; Hoopla increased by 25%; interlibrary loans increased.
  - iv. Tandem Advising: pilot program through Mining and MME, used peer mentors; Navigate system implemented around the same time.
    - Freshman advising in EECS led to pilot program where Chris
      Roman is the main advisor for students in EECS for the first three
      semesters, as well as ME. The number of early alerts in Navigate
      have significantly decreased; students are seeking help and
      accessing available resources (Slide Rule, tutoring, etc).
